## Sub.: Alert SMS/WhatsApp/email in case of serious irregularity found during inspection...reg.

The process of allocation of stock inspection, actual site visit of Inspecting Official (IO) for inspection, preparation of Inspection Report (IR), and submission of the same to the WDRA Office, through courier services, and evaluation at WDRA may take a cycle of about 2-3 months.

Whereas, IO may have found serious irregularities during the stock inspection, for example, damage of stock, down gradation of stock quality, live or expired eNWR/NNWR without stock, damaged roofs, frauds, etc. All such cases require timely action to safeguard interests of stakeholders.

Therefore, in the aforesaid matters, 10% are hereby directed to send a one-page special feature report about serious irregularity found at the warehouse concerning damage of stock, down gradation of stock quality, live or expired eWWR/NWR without stock, damaged roof, frauds, etc., without loss/delay of time. They should immediately send SMS, WhatsApp, and mail from their bloble, laptor, or available PC, or at hardwritten report (scamed by mobile). Aforesaid short special feature report should be sent to Sh Neerupal Yadav DD(SAO) and Sh Dinesh Pabshetwar AD(SA), on their respective WhatsApp Nos. +91-9024554470 and +91-9579166206 along with email IDs as: neerupal.yadav@gov.in. dinesh.pabshetwar@gov.in. and akanksha.wdra?gov.in.
