REVISED GUIDELINES

Revised Guidelines regarding the Capacity Building Program I.e. Warehousemen Training program (WTP) and Assaying Training Program (ATP)

Following two programmes are being organized by WDRA through reputed training partners in the country: -

- 1) Capacity Building Programme for In charge / Managers / Supervisors / representative of warehouseman of the registered warehouses with WDRA (WTP).
- 2) Assaying Training Programme for Quality Control /Technical staff/Secretaries & other representatives looking after assaying activity in WDRA registered warehouses (ATP)

The Warehouse Development and Regulatory Authority (Authority) in its 56th Authority Meeting decided to modify the guidelines which are briefed as under: -

I) Topics for Warehousemen Training Program (WTP): - To increase the theoretical as well as practical knowledge of persons directly engaged in warehousing business.

Note: - Any other additional topic may be added as per the requirement

6	eNWR issuing process and role of two repositories namely NERL and CCRL.	
7	FSSAI, AGMARK and other related Act.	
8	Procedure for ensuring the safety of the goods from fire, theft, burglary etc.	
9	Insurance of stock in registered warehouses	
10	Fire safety and security of stock in registered warehouses.	
11	Practical training through visit to the registered warehouses	
12	Practical demonstration of Assaying of important commodities i.e. Sampling, Analysis and Grading, Stack Plan, Stacking, Spraying and Fumigation.	
13	Quality standards for food grains and other agricultural produce.	

II) Topics for Assaying Training Programme (ATP): -It is a separate programme specifically for technical personnel of the warehouse. However, some topics are same in both WTP and ATP course, but few specific assaying related topics are to be covered in this programme, which are as under: -

S.no	Topics to be covered during ATP
1	Registration of warehouses and their benefits.
2	eNWR issuing process and role of two repositories namely NERL and CCRL and making eNWR as tool of trade
3	Notified commodities and their wholesale market value to be mentioned in the eNWR.
4	Agricultural Commodity Standards of FSSAI, AGMARK, eNAM, Specific Commodity Board and their related Act and Guidelines.
5	Practical Demonstration of Assaying of important commodities i.e. sampling analysis and grading, Stack Plan and stacking, Spraying and Fumigation.
6	Practical training through visit to the registered warehouses and to a nearby AGMARK Laboratory
7	Quality standards for food grains and other agricultural produce.
8	Safety and security of stock in registered warehouses and procedure for ensuring the safety of the goods from fire, theft, burglary etc.

Note: - Any other additional topic may be added as per the requirement

III) Type of participants: - In both the programmes i.e. WTP and ATP, only the representatives of registered warehouses were being considered. It has now been decided that maximum 8 representatives (i.e. 20% of 40 participants per programme) of different unregistered warehouses in a program may also be considered in ATP & WTP along with representatives from registered warehouses.
