Advisory for Applicants for WH registration

Subject: Documentation Requirements for Warehouse Registration Application.

While applying for Warehouse Registration at WDRA portal, Applicants / Warehousemen are requested to provide following documents and requirements along with warehouse Application to enable WDRA to process the Warehouse Registration as per regulation of Warehouse Rules, 2017.

- 1. **Plinth Height Photograph:** The applicant must upload geo-tagged photograph clearly showing the plinth height of the warehouse using a measuring tape.
- 2. **Boundary Wall / Barbed Wire Fencing Photograph:** A clear geo-tagged photograph of the warehouse's boundary wall / barbed wire fencing must be uploaded as part of the application.
- 3. **Fire Equipment Photograph:** A geo-tagged photograph showing the adequate fire safety equipment must be uploaded.
- 4. **Warehouse Name Photograph:** A geo-tagged photograph of the warehouse, clearly displaying the name of the Warehouse at the entrance must be uploaded.
- 5. Previous Application Details (If applicable): If the warehouse application/ instant warehouse has previously applied for registration with the WDRA, the applicant must provide:
 - I. The Application Acknowledgment (ACK) number of the previous application.
 - II. The reason for rejection of the previous application/ warehouse.
- 6. Letter for Safety and Location proximity of the Warehouse: The applicant must submit a letter confirming the following: -
 - "The warehouse is not located within 500 meters of a bone-crushing mill, garbage dumping ground, slaughterhouse, tanneries, hide curing center,

- sewage treatment plant the vicinity of which is deleterious to the safe storage of non-perishable agricultural commodities."
- II. The warehouse is not within 300 meters of kilns, dairies (processing units), or poultry farms.
- III. The warehouse is not located within 150 meters of factories or other sources of fire hazards, such as workshops, hay stacks, timber stores, petrol pumps, CNG stations, LPG bottling plants, etc.
