WDRA Bulletin for April 2024 –June 2024

The Assaying Training Programme, held in June, benefitted 35 warehouse technical staff, enhancing skills in quality assurance. We also celebrated the 10th International Yoga Day in a mass demonstration in New Delhi, reinforcing our commitment to holistic well-being.

I extend my appreciation to the WDRA team for its dedication and perseverance during this quarter. As we look ahead, I am confident that the coming quarters will see further growth with greater outreach and interaction with our stakeholders. Together, we remain committed to building a robust future-ready warehousing sector that meets the needs of a dynamic and growing economy.

CHAPTER I:

EVENTS

A. National Conferences and Programmes:

(i) Presentation explaining functions of WDRA

During the meeting, WDRA Officers gave a presentation explaining functions of WDRA, electronic Negotiable Warehouse Receipt (e-NWR) eco-system and loaning against e-NWR.

B. Awareness and Publicity

(i) Farmers Awareness Programme:-

Media coverage of the Farmers Awareness Programme (FAP), capacity building programmes (WTP) and Assaying Training Programme (ATP) conducted by various institutes to create awareness about WDRA.



(ii) <u>ASSAYING TRAINING PROGRAMME (ATP)</u> for the Technical Staff of Warehouses registered with WDRA, New Delhi conducted on 12.06.2024 to 14.06.2024 at ICM Madurai, Campus. Around 35 Participants were benefited by this programme.

CHAPTER II:

Significant achievements in 1st quarter of 2024-25

(i) Warehouses Registrations

In the first quarter of the 2024-25 financial year, WDRA registered 533 warehouses across India. This milestone supports WDRA's goal to improve storage standards, enhance transparency and promote growth within the warehousing sector, benefiting both agricultural and commercial stakeholders.

(ii) Pledge Finance against eNWRs

During this period, WDRA facilitated pledge loans totaling Rs.2,349.24 crores against electronic Negotiable Warehouse Receipts (e-NWRs). This figure highlights the continued growth and confidence of financial institutions in the WDRA-regulated e-NWR system, which offers secure and standardized collateral options for stakeholders, including farmers and traders, seeking streamlined access to credit.

(iii) Mandatory issuance of e-Negotiable Warehouse Receipt (e-NWR)

Rule 27 of the Warehousing (Development and Regulation) Registration of Warehouses Rules, 2017 was substituted vide G.S.R. 311(E) dated 04.06.2024 that mandated warehousemen to issue negotiable warehouse receipts solely in electronic form and for the same, the Authority may itself function as a repository or register one or more entities as repository, for creation and management of electronic negotiable warehouse receipts.

CHAPTER III: Celebrations in WDRA

On the occasion of 10th International Yoga Day on 21.06.2024, officers of WDRA participated in the Mass Yoga Demonstration held at Tygaraj Stadium, New Delhi led by Hon'ble Minister (CA,F&PD) – Shri Pralhad Joshi to celebrate the theme of "Yoga for Self and Society".
