(a)	the objectives of the Credit Guarantee Scheme for e- NWR based pledge financing (CGS-NPF) aimed at post-harvest financing;	The prime objective of the scheme is to instill confidence among banks and financial institutions to extend pledge finance against e-NWRs to farmers and traders on the agricultural/horticultural produce stored in the WDRA registered warehouses. This schemes provides gurantee to the eligible lending institutions against the credit and warehouseman risk. This scheme is expected to increase the post-harvest finance and enhance credit flow to the farming sector thereby avoiding distress sale and realizing better remunerative prices for the farm produce.
(b)	How the Rs. 1000 crore corpus will benefit small and marginal farmers, women, SC, ST and Divyangjan;	The CGS-NPF is focused on the beneficiaries such as small and marginal farmers, women, SC/ST and Divyangjan farmers. They were provided with higher guarantee coverage, i.e. 80-85 % and lower guarantee fee, i.e. 0.4%. For non-farmer borrower, guarantee fee is fixed at 1 % per annum. Therefore, the scheme is expected to benefit the above said beneficiaries and banks would be encouraged to extend loans to them.
