- **G.S.R.** 251(E).—In exercise of the powers conferred by clauses (a), (b) and (c) of sub-section (2) of section 50 of the Warehousing (Development and Regulation) Act, 2007 (37 of 2007), the Central Government hereby makes the following rules further to amend the Warehousing (Development and Regulation) Registration of Warehouses Rules, 2017, namely:-
- 1. **Short title and commencement.** (1) These rules may be called the Warehousing (Development and Regulation) Registration of Warehouses (Amendment) Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Warehousing (Development and Regulation) Registration of Warehouses Rules, 2017, for the Seventh Schedule, the following schedule shall be substituted, namely:-
