** Qualitative specifications / standards for above commodities will be of Agmark. However, in case, Agmark standards do not exist, for those commodities quality standards laid down by the Central / State Governments / Government bodies shall be applicable viz:

- (i) For Tea, Tea Board specifications would be followed.
- (ii) For Coffee, Indian Coffee Board specifications will be followed.
- (iii) For Rubber, the BIS specifications would be followed.
- (iv) For Indian sugar, BIS specifications would be followed.

Note:

I. For commodities requiring chemical or allied laboratory analysis, all Agmark laboratories, all accredited laboratories notified by National Accreditation Board for Testing and Calibration and laboratories recognised by Bureau of Indian Standards (BIS), are authorised for laboratory testing.

II. In addition, all Central / State Government laboratories and other laboratories recognised by them for testing of commodities are authorised for laboratory testing.
