NOTICE

Subject: Inviting feedback/comments of stakeholders on the proposed shelf life for storage of notified commodities under eNWR

Warehousing Development and Regulatory Authority (WDRA) invites feedback on the proposed shelf life for the notified commodities as per Annexure-I.

As per para 11 (1) (o) of the Warehousing (Development and Regulation) Act, 2007, A warehouse receipt, which may be either in writing or in electronic form, shall be a document of title to goods in writing if it contains declared shelf-life of the goods. Further, as per para 11 (1) (q) of the said Act, the receipt would be valid only till the date of expiry of declared shelf-life of the goods for which it is issued.

Hence, it is required that a shelf-life be declared for all goods that are supposed to be stored under an eNWR in a WDRA registered warehouse.

The feedback/ comments on the proposed shelf life of the various commodities may be submitted by email to adsrr-wdra@gov.in as per the format in Annexure-II by 10.05.2026.
