Warehousing Development and Regulatory Authority

Boards, Councils, Committees & other bodies consisting of two or more persons constituted as its part or for the purpose of its advice:

- (i) Name of Boards, Council, Committee etc.
 - a. Authority
 - b. Warehousing Advisory Committee(WAC)
- (ii) Composition of Authority: As per Sec 25 of the W(D&R) Act 2007, the Authority shall consist of-
 - (a) A Chairperson; and
 - (b) not more than two other members, to be appointed by the Central Government from amongst persons of ability, integrity and standing who have wide knowledge and experience in inventory management, insurance, preservation, quality control, agriculture banking, finance, economics, law or administration.

- a. The Warehousing Development and Regulatory Authority (WDRA) was constituted on 26.10.2010 under the Warehousing (Development and Regulation) Act, 2007 vide Government of India Gazette Notification dated 26th October 2010.
 - b. WAC was constituted vide Gazette Notification dated 13th January 2011
- (v) Powers and functions:
- a. Power and functions of the Authority are given under Sec 35 of the W(D&R) Act, 2007
 - b. Function of WAC:
- As per section 34 (1) of the Warehousing (Development and Regulation) Act, 2007, WDRA may constitute a Warehousing Advisory Committee for the following are:-
- (i) To advise the WDRA on the matters of Regulation under Section 51.
 - (ii) To make recommendations for the effective implementation of the provisions of this Act.
 - (iii) To advise the Authority on such matters as may be referred by the Authority

BOARDS, COUNCILS, COMMITTEES AND OTHER BODIES CONSTITUTED AS PART OF THE PUBLIC AUTHORITY

I. Authority [as per Sec.25 and 26 of the Warehousing (Development and Regulation) Act, 2007]

A. The Authority shall consist of:

- (a) a Chairperson; and
- (b) not more than two other members, to be appointed by the Central Government from amongst persons of ability, integrity and standing who have wide knowledge and experience in inventory management, insurance, preservation, quality control, agriculture banking, finance, economics, law or administration

B. Tenure of office of Chairperson and other members:

The Chairperson and every other member shall hold office for a term not exceeding five years from the date on which he enters upon his office and shall be eligible for reappointment. Provided that no person shall hold office as the Chairperson or other member after he has attained the age of sixty-five years.

II. Warehousing Advisory Committee [as per Sec. 34 of the Warehousing (Development and Regulation) Act, 2007]

The Authority may, by notification, constitute a Committee to be known as the Warehousing Advisory Committee to advise the Authority on matters relating to the making of regulations under section 51 of the W(D&R) Act 2007 and make recommendations for effective implementation of the provisions of this Act.

The Warehousing Advisory Committee shall consist of not more than fifteen members excluding the members of the Authority to represent the interests of commerce, industry, engineering, agriculture, consumers, organizations engaged in warehousing, quality control, preservation and research bodies.
